RULES AND REGULATIONS OF PARTICIPATION

Participation: ISF/IFCOMA reserves the right to select participants/exhibits to be displayed at its sole discretion.

Space Allocation: Application completed in all respects and accompanied by the requisite payment will only be considered for allocation of space. Space will be allocated product category – wise.

Last date: Applications for space booking together with full amount of participation fee must be submitted latest by 30 April 2011.

Refund: No refund/adjustment of participation fee will be made by the organizers.

Possession of stall will be given only after clearance of all dues by the participants

Display of Exhibits: The Exhibitors will display only products manufactured / traded by them as declared in the brochure.

Sub-renting of space is strictly prohibited

No display aid or products is allowed outside the allotted stall, participants to ensure that space outside the stall area is **not encroached upon** in any way.

Cleanliness and maintenance: The participants will be responsible for cleanliness and maintenance of their stalls. Cleaning of common passage/areas will be arranged by the organizers.

Attendance at the Stand: The participants will carry out no activity, which in the opinion of the organisers amounts to nuisance or annoyance. Organizers shall have the right to take remedial action as deemed fit.

Fire Prevention: Smoking is prohibited inside the exhibition halls. Halogen and other floodlight are not permitted.

Security: Participants will be responsible for security of their exhibits and stall during the exhibition. However the organizers will make security arrangements of all the stalls.

Insurance: Participants are responsible for insuring their exhibits and display material against loss, damage, theft, fire or any cause whatsoever.

Sound Level: The sound level inside the hall/stand/pavilion is to be maintained for the general comfort of all exhibitors and visitors. The sound level should not exceed 70 decibel on account of use of any sound/music system by the exhibitor.

Vacation of space: Space will have to be vacated by 20:00 hours on 10 July 2011.

Violation of Rules: In the event of violation of any of the rules, ISF/IFCOMA shall have the right to close down the stall of the participant immediately.

Interpretation: The decisions of President ISF and IFCOMA or his nominee shall be final and binding on the participants with regard to interpretation of these rules and regulations.

Disputes: Disputes, if any, arising out of participation in the fair fall within the jurisdiction of the courts of Chennai / Noida

ISF/IFCOMA will not be responsible for any eventuality arising out of unforeseen circumstance, natural calamity like, floods, fires etc.
